DONNING PPE

Evaluator tells candidate: “Prepare your PPE for donning. After you have arranged your PPE you will need to tell me when you are ready. After you are ready, time will start whenever you touch any part of your PPE.”

Don pants and boots according to manufacturer’s guidelines, which includes suspenders in place.				
Don hood.				
Don coat, including storm flap closed and collar up.				
Don helmet.				
Don gloves.				
Dons above listed equipment within 60 seconds and according to manufacturers guidelines (candidate claps hands to signal completion of task).				

DONNING SCBA

Evaluator tells candidate: “Prepare your SCBA for donning. After you have arranged your SCBA you will need to tell me when you are ready. After you are ready, time will start whenever you touch any part of your SCBA or face piece.”

Dons SCBA according to manufacturer’s guidelines.				
Valves fully opened (cylinder/mainline).				
Dons facepiece according to manufacturer’s guidelines.				
Dons and activates Full PPE and SCBA (except gloves and PASS) within 60 seconds (candidate claps hands to signal completion of step).				
All PPE donned and no skin is exposed to atmosphere.				
Manual PASS device: Activates PASS device in “normal” mode.				
Integrated PASS device: Verbalizes that PASS device is activated.				
Total steps candidate must complete to pass:	12	Total
