The candidate, while operating as a member of a team and under direct supervision, will extinguish a fire located at ground level within a structure. The candidate shall expose, separate, remove and relocate charred material to a safe location and identify and preserve obvious signs of area of origin and arson.

Wears full PPE and SCBA on Air.				
Calls for ventilation prior to entry				
Bleeds attack line and adjust nozzle prior to entry.				
Communicates with partner				
Stay low on entering and approaching fire				
Correctly extinguishes the fire using pattern proctor or officer chooses.				
Shuts down nozzle so that water hammer is avoided				
Ventilates structure using hydraulic ventilation methods.				
<u>Circle attack pattern directed to use</u>

<b>OVERHAUL</b>				
Wears full PPE and SCBA on air				
Overhaul fire scene				
Evidence of fire cause/origin is found				
Candidate informs command about evidence found				
<b>PRESERVE AND PROTECT</b>				
Charred material left in place until cleared by fire investigator.				
Delay salvage/overhaul as necessary				
Minimize water and other damage but still completes overhaul assignment without destroying evidence of fire cause/origin.
